3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE AN AGREEMENT, AND ANY  
6 NECESSARY DOCUMENTS INCLUDING SUBSEQUENT  
7 AMENDMENTS, WITH BRAGG INVESTMENT COMPANY,  
8 INC., DBA COASTLINE EQUIPMENT, A LONG BEACH  
9 DISTRIBUTOR OF JOHN DEERE CONSTRUCTION  
10 RETAILS SALES, OF MOLINA, IL, FOR THE PURCHASE  
11 OF A JOHN DEERE 310L BACKHOE LOADER, WITH  
12 RELATED EQUIPMENT AND ACCESSORIES, ON THE  
13 SAME TERMS AND CONDITIONS THROUGH THEIR  
14 CONTRACT WITH SOURCEWELL (FORMERLY THE  
15 NATIONAL JOINT POWERS ALLIANCE) IN AN AMOUNT  
16 NOT TO EXCEED \$158,541, INCLUDING TAXES AND  
17 FEES

19 WHEREAS, the Charter of the City of Long Beach (the "City"), Section  
20 1802, permits the City to purchase services, supplies, materials, equipment and labor  
21 with other government agencies by purchasing under their contracts on a voluntary and  
22 selective basis when authorized by resolution; and

23 WHEREAS, the City desires to purchase a John Deere 310L Backhoe  
24 Loader, including a compaction wheel and two loader buckets and other accessories,  
25 which are necessary for optimal utilization by the Public Works Department; and

26 WHEREAS, this unit is an approved FY18 replacement and will be used by  
27 the Public Works Department, Street Maintenance Division, for excavation of old  
28 pavement, transportation of construction material and removal of construction debris; and

1           WHEREAS, the cooperative agreement options were reviewed and it was  
2 determined that the contract between Sourcewell and John Deere provided the best  
3 value for the City; and

4           WHEREAS, Sourcewell has a contract for the purchase of a John Deere  
5 310L Backhoe Loader, with related equipment and accessories, Contract No. 032119-  
6 JDC (“Sourcewell Contract”); and

7           WHEREAS, the City’s participation in the Sourcewell Contract will facilitate  
8 the City’s ability to purchase as well as provide considerable cost benefits to the City; and

9           WHEREAS, if the City had to utilize a formal bid process rather than  
10 participate in the Sourcewell Contract considerably more funds would be required;

11           NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
12 follows:

13           Section 1.    The above recitals are true and correct and are incorporated  
14 herein by this reference.

15           Section 2.    The City Manager or designee is hereby authorized to enter  
16 an agreement with John Deere Construction Retail Sales to purchase a John Deere 310L  
17 Backhoe Loader, including a compaction wheel and two loader buckets and other  
18 accessories, of the same type and kind identified in the Sourcewell Contract except as  
19 modified by mutual agreement of the City and John Deere Construction Retail Sales, and  
20 the purchase by the City shall be on the same terms and conditions afforded to  
21 Sourcewell in an amount not to exceed One Hundred Fifty Eight Thousand Five Hundred  
22 Forty-One Dollars (\$158,541) including tax and fees.

23           Section 3.    This resolution shall take effect immediately upon its adoption  
24 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
