1 FIRST AMENDMENT TO AGREEMENT NO. 33774

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33774 is made and
4 entered, in duplicate, as of August 5, 2015, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 6, 2015, by and between CSG CONSULTANTS, INC., a California corporation
7 ("Consultant"), with a place of business at 801 Park Center Drive, Suite 230, Santa Ana,
8 California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed plan review and inspection services; and

11 WHEREAS, the parties entered Agreement No. 33774 whereby Consultant
12 agreed to provide these Services; and

13 WHEREAS, the parties desire to increase the Agreement amount by
14 \$50,000 for a total not to exceed amount of \$80,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions in this Agreement, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 33774 is hereby amended to read as
18 follows:

19 "1. SCOPE OF WORK OR SERVICES.

20 A. Consultant shall furnish specialized services more particularly
21 described in Exhibit "A", attached to this Agreement and incorporated by this
22 reference, in accordance with the standards of the profession, and City shall pay
23 for these services in the manner described below, not to exceed Eighty Thousand
24 Dollars (\$80,000), at the rates or charges shown in Exhibit "B".

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 33774 are ratified and confirmed and shall remain in full
27 force and effect.
