## FIRST AMENDMENT TO AGREEMENT NO. 33774 33774

THIS FIRST AMENDMENT TO AGREEMENT NO. 33774 is made and entered, in duplicate, as of August 5, 2015, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 6, 2015, by and between CSG CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 801 Park Center Drive, Suite 230, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, the parties entered Agreement No. 33774 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to increase the Agreement amount by \$50,000 for a total not to exceed amount of \$80,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 1.A. of Agreement No. 33774 is hereby amended to read as follows:

## "1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Eighty Thousand Dollars (\$80,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33774 are ratified and confirmed and shall remain in full force and effect.
