THIS SECOND AMENDMENT to Agreement No. 31012 and Supplemental Agreement is made and entered, in duplicate, as of August 6, 2010, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 2, 2008, by and between COMMUNITY HOSPITAL OF LONG BEACH, a public benefit corporation, whose address is 1720 Termino Avenue, Long Beach, California 90804 ("HOSPITAL"), and the CITY OF LONG BEACH, a municipal corporation ("CITY").

WHEREAS, the parties entered into Agreement No. 31012 on January 22, 2009, wherein Hospital agreed to provide emergency medical services with respect to persons booked into the Long Beach City Jail and in the custody of Long Beach Police Department ("LBPD") and victims of certain crimes on behalf of City; and

WHEREAS, the parties executed the Supplemental Agreement to Agreement No. 31012 on February 17, 2009, to extend the medical services provided; and

WHEREAS, the parties executed the First Amendment to Agreement No. 31012 and the Supplemental Agreement on October 22, 2009, to extend the term; and

WHEREAS, the parties desire to execute the final option to extend the term of both Agreements;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein, the parties agree as follows:

Section 1. Section "G" of Agreement No. 31012 is hereby amended in its entirety to read as follows:

"G. The term of this Agreement shall commence at midnight on October 1, 2008, and shall terminate at 11:59 p.m. on September 30, 2011.
