RECOMMENDATION:

Authorize the City Manager to execute a Public Walkways Occupancy Permit for sidewalk dining at Bo-Beau Kitchen located at 144 Pine Ave. (District 2)

DISCUSSION

Tupelo Restaurants, Inc., the business owner of Bo-Beau Kitchen, requests a permit to temporarily occupy part of the adjoining sidewalk, at 144 Pine Avenue, with portable fixtures for the purpose of sidewalk dining. The proposed permit area and a list of furnishings and accessories to be placed in the permit area are shown on the attachment. Approval of this permit is based on the conditions and standards of Chapter 14.14 of the Long Beach Municipal Code, which describes temporary uses of public right-of-way.

The width of the sidewalk at this location is 22 feet. An 8-foot clear path will be maintained between the streetlight, located immediately adjacent to the area of the proposed barricade and the curb line, and a 10-foot clear path will remain between the permit area barricade and curb line.

This matter was reviewed by the Long Beach Fire Department on August 6, 2014, and by Deputy City Attorney Linda Vu and Budget Management Officer Victoria Bell on September 24, 2014.

TIMING CONSIDERATIONS

City Council action on this matter is requested for the October 14, 2014, to allow the business owner to open the restaurant operations in October.

FISCAL IMPACT

A permit-processing fee of \$1,700 was deposited into the General Fund (GF) in the Public Works Department (PW) and a security deposit of \$1,805 was provided to assure sidewalk repairs upon permit termination. Approval of this recommendation will provide continued support to the local economy.




