**RECOMMENDATION:**

Receive the application of The Corner 10th's BBQ, LLC, dba The Corner 10th's BBQ, for an original application of an Alcoholic Beverage Control (ABC) License, at 3200 East 10th Street, submit a Public Notice of Protest to ABC; and, direct the City Manager to withdraw the protest if a Conditional Use Permit Exemption (CUPEX) is granted. (District 2)

DISCUSSION

It is City Council policy to review applications for ABC licenses to determine if a basis for protest against the issuance of the license exists. The attached application lists the possible basis for protest.

TIMING CONSIDERATIONS

The Department of Alcoholic Beverage Control received the above application on November 3, 2022. The applicant is still in the planning stages and has not yet received a CUPEX. Provided the Planning Commission approves the CUPEX, the recommendation includes a request to direct the City Manager to withdraw the Public Notice of Protest. City Council action is requested on December 13, 2022, to respond to the Department of Alcoholic Beverage Control by the December 23, 2022 due date.


FISCAL IMPACT


