

1 **FIRST AMENDMENT TO AGREEMENT NO. 31012**

2 **AND SUPPLEMENTAL AGREEMENT**

4 THIS FIRST AMENDMENT to Agreement No. 31012 and Supplemental  
5 Agreement is made and entered, in duplicate, as of September 15, 2009, for reference  
6 purposes only, pursuant to a minute order adopted by the City Council of the City of Long  
7 Beach at its meeting on September 2, 2008, by and between COMMUNITY HOSPITAL  
8 OF LONG BEACH, a public benefit corporation, whose address is 1720 Termino Avenue,  
9 Long Beach, California 90804 ("HOSPITAL"), and the CITY OF LONG BEACH, a  
10 municipal corporation ("CITY").

11 WHEREAS, the parties entered into Agreement No. 31012 on January 22,  
12 2009, wherein Hospital agreed to provide emergency medical services with respect to  
13 persons booked into the Long Beach City Jail and in the custody of Long Beach Police  
14 Department ("LBPD") and victims of certain crimes on behalf of City; and

15 WHEREAS, the parties executed the Supplemental Agreement to  
16 Agreement No. 31012 on February 17, 2009, to extend the medical services provided;  
17 and

18 WHEREAS, the parties now desire to extend the term of both Agreements;  
19 NOW, THEREFORE, in consideration of the mutual terms, covenants and  
20 conditions herein, the parties agree as follows:

21 Section 1. Section "G" of Agreement No. 31012 is hereby amended in its  
22 entirety to read as follows:

23 "G. The term of this Agreement shall commence at midnight on October  
24 1, 2008, and shall terminate at 11:59 p.m. on September 30, 2010. CITY shall have an  
25 option to renew this Agreement by amendment for one (1) additional one (1) year period  
26 from the date of the expiration hereto, at the discretion of the Long Beach City Manager."

27 Section 2. Section "C" of the Supplemental Agreement to Agreement No.  
28 31012 is hereby amended in its entirety to read as follows:

1 "C. The term of this Agreement shall commence at midnight on October  
2 1, 2008, and shall terminate at 11:59 p.m. on September 30, 2010. CITY shall have an  
3 option to renew this Agreement by amendment for one (1) additional one (1) year period  
4 from the date of the expiration hereto, at the discretion of the Long Beach City Manager."

5 Section 3. Except as expressly amended herein, all of the terms,  
6 covenants, and conditions of Agreement No. 31012 and the Supplemental Agreement, as  
7 amended, and to the extent non contrary to this First Amendment, shall remain  
8 unchanged and in full force and effect.
