Dear Councilwoman Schipske:

As the founding members of the Plaza Neighborhood Association we oppose the opening of another liquor store in our neighborhood. As you know the M & M Liquor Store formerly housed at 3122 Los Coyotes Diagonal received Council approval to move to 3020 Woodruff. We did not protest this move since M & M has been a good business partner in our neighborhood for some time.

Now, however, the owner of the building complex (Sopha Thai) where M & M was previously housed is applying to open another liquor store at the 3122 Los Coyotes Diagonal location - meaning there will be two liquor stores within two blocks of each other a neighborhood that already has five grocery stores and a Rite Aide within a six block radius of our association boundaries. Rite Aide and four of the grocery stores sell liquor and all six of the stores sell beer and wine. *It is our hope that you and the other council members agree that the opening of another store that sells liquor is not reasonable or necessary.*



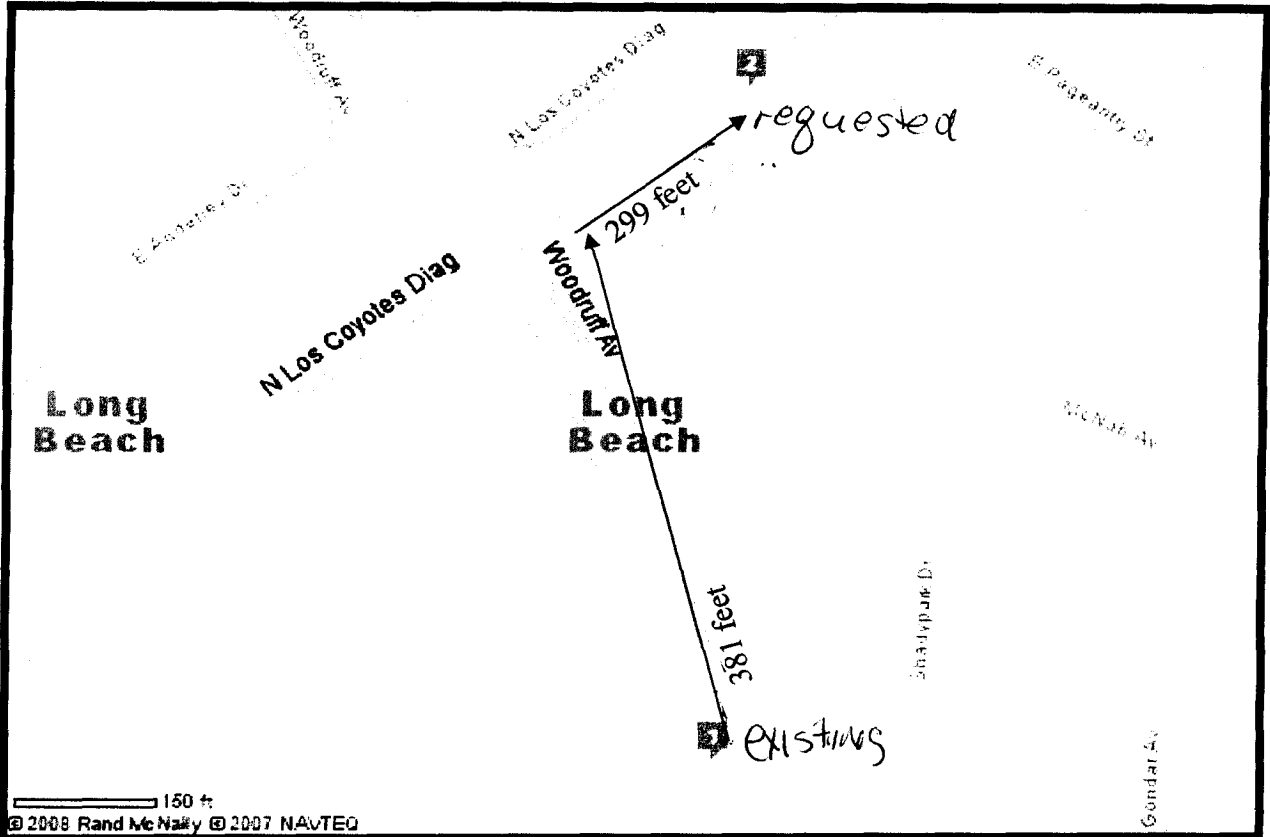

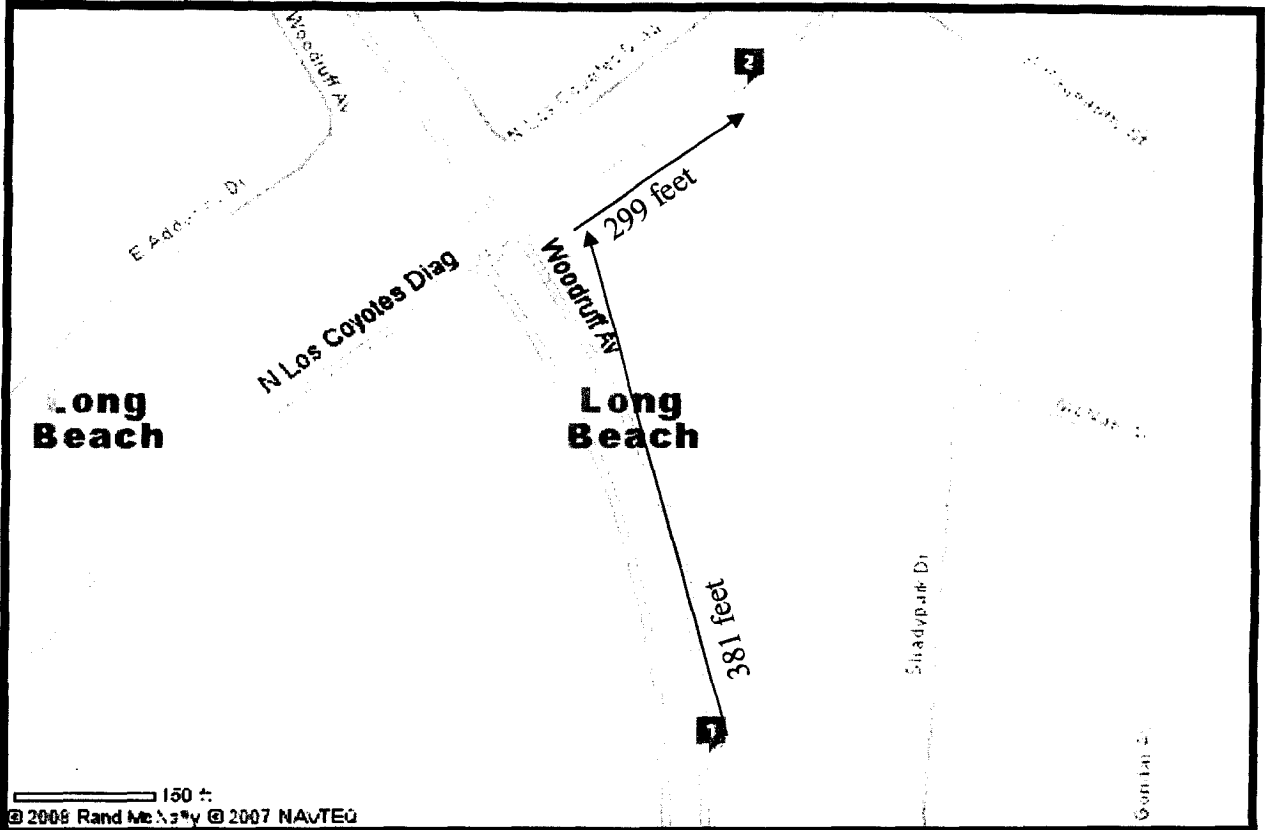
