As the founding members of the Plaza Neighborhood Association we oppose the opening of another liquor store in our neighborhood. As you know the M & M Liquor Store formerly housed at 3122 Los Coyotes Diagonal received Council approval to move to 3020 Woodruff. We did not protest this move since M & M has been a good business partner in our neighborhood for some time.

Now, however, the owner of the building complex (Sophan Thai) where M & M was previously housed is applying to open another liquor store at the 3122 Los Coyotes Diagonal location - meaning there will be two liquor stores within two blocks of each other a neighborhood that already has five grocery stores and a Rite Aide within a six block radius of our association boundaries. Rite Aide and four of the grocery stores sell liquor and all six of the stores sell beer and wine. It is our hope that you and the other council members agree that the opening of another store that sells liquor is not reasonable or necessary.






