(C)	3	Provide R30 insulation at the underside of the roof decks in buildings 1301 and 1327 in accordance with COR-3 as directed by the Project Manager
(A)	4	Replace plumbing for ADA toilet per RFI 3 in accordance with COR-4 as directed by the Project Manager \$ 3,446.45
(C)	5.	Perform camera inspection of existing drain lines in accordance with COR-5 as directed by the Project Manager \$ 1,676.39
(C)	6.	Relocate Drinking Fountain per Field Sketch in accordance with COR-6 as directed by the Project Manager \$ 430.81
(C)	7.	Perform ground penetrating radar survey of the slabs on grade in buildings 1301 and 1327 to determine if voids similar to that discovered in building 1327 exist in accordance with COR-7 as directed by the Project Manager
(C)	8 *	Provide 2 - 4" conduit sleeves at electrical room 125 and 2 - 4" conduit sleeves in masonry walls of buildings 1301 and 1327 for voice/data cable in accordance with COR-8 as directed by the Project Manager

Provide additional electrical/voice/data outlets and revise door location in Room 108 in accordance with COR-9 as directed by the 

#### TOTAL ESTIMATED INCREASE TO CONTRACT COST .
