RESOLUTION NO. RES-18-0062

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH CERTIFYING THE RESULTS OF THE CONSOLIDATED PRIMARY NOMINATING ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, APRIL 10, 2018, FOR THE PURPOSE OF NOMINATING AND/OR ELECTING CANDIDATES FOR ONE (1) OFFICE ON THE GOVERNING BOARD OF THE LONG BEACH UNIFIED SCHOOL DISTRICT, AND FOR ONE (1) OFFICE ON THE BOARD OF TRUSTEES OF THE LONG BEACH COMMUNITY COLLEGE DISTRICT

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-17-0125, duly call and provide for the holding of a Primary Nominating Election on Tuesday, April 10, 2018, for the purpose of nominating and/or electing candidates for the office of Mayor and the offices on the City Council namely, for the Third, Fifth, Seventh and Ninth Districts; and

WHEREAS, on October 24, 2017, the City Council adopted Resolution No. RES-17-0127 consenting to the requests of the Board of Education of the Long Beach Unified School District and the Board of Trustees of the Long Beach Community College District to consolidate the Governing Board Member elections for said Districts pursuant to the provisions of Section 10400 of the California Elections Code with the City's Primary Nominating Election for the purpose of nominating and/or electing candidates for one (1) office on the Board of Education of the Long Beach Unified School District for a full term of four (4) years, commencing on the third Monday of July, 2018, and for one (1) office on the Board of Trustees of the Long Beach Community College District, for a full term of four (4) years, commencing on the third Monday of July, 2018; and

1 WHEREAS, the consolidated election was held in the City of Long Beach
2 on April 10, 2018; and

3 WHEREAS, the City Clerk, pursuant to Long Beach Municipal Code Section
4 1.21.010, duly canvassed the returns of the election, including the Vote by Mail ballots
5 issued in connection with the election which were returned as required by law;

6 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
7 follows:

8 Section 1. That the Vote by Mail ballots issued in connection with the
9 election which have been returned as required by law have been duly canvassed, and
10 the results of that count have been recorded. That the City Clerk has duly canvassed the
11 returns of the election held on April 10, 2018, for Member of the Board of Education of
12 the Long Beach Unified School District and for Member of the Long Beach Community
13 College District, and has filed a Certificate of Canvass with the City Council and from that
14 certification the City Council finds that the total number of votes cast in each district, the
15 total number of votes cast in each of the respective election precincts established for the
16 election, the number of votes cast for each candidate in each precinct and the total
17 number of votes for each candidate are as provided in Exhibit "A" attached to and made a
18 part of this resolution.

19 Section 2. That the candidates nominated as required by law for the one
20 (1) office of Member of the Board of Trustees of the Long Beach Community College
21 District were:

22 Trustee Area 1: Jeffrey A. Kellogg
23 Uduak-Joe Ntuk

24 Section 3. That said candidates for the office of Member of the Board of
25 Trustees of the Long Beach Community College District received the number of votes
26 indicated in Exhibit "A" from those precincts listed on said Exhibit "A".

27 Section 4. That Uduak-Joe Ntuk received a majority of the votes cast for
28 all candidates for the office of Member of the Board of Trustees of the Long Beach

1 Community College District, Trustee Area 1, and is declared elected to such office for the
2 full term of four (4) years commencing with the third Monday of July, 2018.

3 Section 5. That the candidates nominated as required by law for one (1)
4 office of Members of the Board of Education of the Long Beach Unified School District
5 were:

- 6 District 3: Cesar A. Armendariz
7 Juan M. Benitez
8 Eduardo Lara

9 Section 6. That said candidates for the office of Member of the Board of
10 Education of the Long Beach Unified School District received the number of votes
11 indicated in Exhibit "A" from those precincts listed on said Exhibit "A".

12 Section 7. That the following are declared nominated for the office of
13 Member of the Board of Education of the Long Beach Unified School District, District 3:

- 14 District 3: Juan M. Benitez
15 Cesar A. Armendariz

16 They are nominated for the office of Member of the Board of Education of
17 the Long Beach Unified School District, District 3, for the full term of four (4) years
18 commencing on the third Tuesday of July, 2018, and the City Clerk is directed to place
19 their respective names on the ballots to be used at the General Municipal Election to be
20 held on the 5th day of June, 2018.

21 Section 8. This resolution shall take effect immediately upon its adoption
22 by the City Council, and the City Clerk shall certify the vote adopting this resolution. The
23 City Clerk shall further spread this resolution on the minutes of this City Council, which
24 entry shall constitute the City Clerk's statement and certification of the result of the
25 election.
