THIS SECOND AMENDMENT TO PERMIT NO. 29258 is made and entered, in duplicate, as of April 14, 2009, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 2, 2005, by and between THE CITY OF LONG BEACH, a Municipal corporation ("City") and MEL-O-DEE ICE CREAM ("Permittee").

WHEREAS, City granted Permittee permission to sell ice cream products from mobile ice cream vehicles at certain locations; and

WHEREAS, the parties desire to amend this permit by extending the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Permit No. 29258, the parties agree as follows:

1. Section 1 of Permit No. 29258 is hereby amended in its entirety to read as follows:

"1. The initial term of this Permit shall commence on August 3, 2005 and shall terminate on July 31, 2008. The second extended term of this Permit shall commence on August 1, 2009 and shall terminate on July 31, 2010. "

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. 29258 are ratified and confirmed and shall remain in full force and effect.
