3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT WITH DEERE
6 & COMPANY FOR THE PURCHASE OF ONE (1) JOHN
7 DEERE 7210R TRACTOR, WITH RELATED EQUIPMENT
8 AND ACCESSORIES, THROUGH THE NATIONAL JOINT
9 POWERS ALLIANCE (NJPA)

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
12 1802, permits the City to purchase services, supplies, materials, equipment and labor
13 with other government agencies by purchasing under their contracts on a voluntary and
14 selective basis when authorized by resolution; and

15 WHEREAS, the City desires to purchase one (1) John Deere 7210R tractor,
16 with related equipment and accessories, from Deere & Company; and

17 WHEREAS, the National Joint Powers Alliance (NJPA) has a contract for
18 the procurement of agricultural tractors and implements together with related equipment
19 and accessories under Contract No. 031711-DAC ("NJPA Contract"); and

20 WHEREAS, the City's participation in the NJPA Contract will facilitate timely
21 acquisition of the John Deere 7210R tractor as well as provide considerable cost benefits
22 to the City; and

23 WHEREAS, if the City had to utilize a formal bid process rather than
24 participate in the NJPA Contract considerably more funds would be required;

25 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
26 follows:

27 Section 1. The above recitals are true and correct and are incorporated
28 herein by this reference.

1 Section 2. The City Manager of the City is hereby authorized to enter an
2 agreement with Deere & Company for the purchase of (1) John Deere 7210R tractor, with
3 related equipment and accessories, of the same type and kind identified in the NJPA
4 Contract except as modified by mutual agreement of the City and Deere & Company, in
5 an amount not to exceed One Hundred Seventy-Two Thousand Seven Hundred Twenty-
6 Seven Dollars and Ten Cents (\$172,727.10), including tax, on the same terms and
7 conditions as the NJPA Contract.

8 Section 3. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

10 I hereby certify that the foregoing resolution was adopted by the City
11 Council of the City of Long Beach at its meeting of April 7, 2015,
