## THIRD AMENDMENT TO AGREEMENT NO. 33460

THIS THIRD AMENDMENT TO AGREEMENT NO. 33460 is made and entered, in duplicate, as of May 17, 2019 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 14, 2019, by and between GHD INC., a California corporation, with a place of business at 320 Goddard Way, Suite 200 16451 Scientific Way, Irvine, California 92618 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with on-call street design consulting services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33460 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to update the City representative and extend the term to April 30, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$800,000 for a total not to exceed amount of \$1,800,000 and extend the term to April 30, 2019; and

WHEREAS, the Parties desire to extend the term one (1) additional one- year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on May 1, 2014, and shall terminate at 11:59 p.m. on April 30, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33460 are ratified and confirmed and shall remain in full force and effect.
