

1 FIRST AMENDMENT TO AGREEMENT NO. 35393

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35393 is made and
4 entered, in duplicate, as of August 25, 2020 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on August
6 20, 2019, by and between AECOM TECHNICAL SERVICES, INC., a California corporation
7 ("Consultant"), with a place of business at 300 South Grand Avenue, 9th Floor, Los
8 Angeles, California 90071, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 35393 (the "Agreement") whereby Consultant agreed to provide as-needed, on-call
12 consulting services for street design projects; and

13 WHEREAS, the Parties desire to reduce the total not to exceed amount of
14 the Agreement by \$500,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 1.A. of the Agreement is hereby amended to read as follows:

18 "A. Consultant shall furnish specialized services more particularly
19 described in Exhibit "A", attached to this Agreement and incorporated by this
20 reference, in accordance with the standards of the profession, and City shall pay for
21 these services in the manner described below, in an amount not to exceed Five
22 Hundred Thousand Dollars (\$500,000), at the rates or charges shown in Exhibit "B"."

23 2. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 35393 are ratified and confirmed and shall remain in full force
25 and effect.


