

## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE  
AN AGREEMENT WITH VERIZON CALIFORNIA, INC. WITHOUT  
ADVERTISING FOR BIDS FOR THE RELOCATION OF VERIZON  
SECONDARY DEMARCATION POINTS AT THE LONG BEACH  
MARINAS

WHEREAS, as part of the rebuild of the Marinas, it is necessary for Verizon  
to relocate their secondary demarcation points around the Marinas; and

WHEREAS, using Verizon as a single source for the services eliminates the  
problem of one vendor claiming they cannot fix a problem due to the fault of another party;  
and

WHEREAS, Verizon owns the system and must perform work on its own  
system; and

WHEREAS, no useful purpose would be served by advertising for bids for  
these services and to do so would constitute an idle and useless act and an unnecessary  
expenditure of public funds;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
follows:

Section 1. That the above recitals are true and correct and are incorporated  
herein.

Sec. 2. The City Manager is hereby authorized to enter into an agreement  
with Verizon California, Inc. for relocation of Verizon secondary demarcation points at the  
Long Beach Marinas in an amount not to exceed Seven Hundred Fifty Thousand Dollars  
(\$750,000.)

Sec. 3. This resolution shall take effect immediately upon its adoption by the
