3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34328 is made and
4 entered, in duplicate, as of May 19, 2021, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on July 12, 2016,
6 by and between GRAFFITI PROTECTIVE COATINGS, INC. a California corporation with
7 a place of business at 419 N. Larchmont Boulevard, #264, Los Angeles, California 90004
8 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
10 34328 (the "Agreement") whereby Contractor agreed to provide graffiti removal services;
11 and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 attach a revised rate sheet and extend the term to June 31, 2020; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to extend the term to June 31, 2021 and add the authorize annual amount; and

16 WHEREAS, the Parties desire to extend the term one (1) additional one-year
17 period and add the authorized annual amount;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the Parties agree as follows:

- 20 1. Section 2 of the Agreement is hereby amended to read as follows:
- 21 "2. TERM. The term of this Agreement shall commence at midnight on
22 August 1, 2016, and shall terminate at 11:59 p.m. on July 31, 2022, unless sooner
23 terminated as provided in this Agreement, or unless the services or the Project is
24 completed sooner. The term can be extended for two (2) additional one-year periods, at
25 the discretion of the City Manager."

- 26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 34328 are ratified and confirmed and shall remain in full force
28 and effect.
