

1 THIRD AMENDMENT TO AGREEMENT NO. 34661

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34661 is made and  
4 entered, in duplicate, as of March 29, 2021, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on June  
6 13, 2017, by and between RDC-S111, INC. DBA STUDIO 111, a California corporation  
7 ("Consultant"), with a place of business at 245 E. Third Street, Long Beach, California  
8 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 34661 (the "Agreement") whereby Consultant agreed to provide as needed urban planning  
11 design services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
13 add \$200,000 for a total not to exceed amount of \$800,000 and extend the term to June  
14 30, 2020; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
16 to extend the term to June 30, 2021; and

17 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
18 period;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
20 conditions herein contained, the Parties agree as follows:

21 1. Section 2 of the Agreement is hereby amended to read as follows:

22 "2. TERM. The term of this Agreement shall commence at midnight on  
23 July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2022, unless sooner terminated  
24 as provided in this Agreement, or unless the services or the Project is completed sooner."

25 2. Except as expressly modified herein, all of the terms and conditions  
26 contained in Agreement No. 34661 are ratified and confirmed and shall remain in full force  
27 and effect.


