3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH THE
6 BOLDER GROUP, INC., WITHOUT ADVERTISING FOR
7 BIDS, FOR FURNISHING AND DELIVERING MARINE
8 FUEL FOR A PERIOD OF ONE YEAR WITH THE OPTION
9 TO RENEW FOR THREE ADDITIONAL ONE-YEAR
10 PERIODS IN AN ANNUAL AMOUNT NOT TO EXCEED
11 \$150,000

13 WHEREAS, the recent addition of grant-funded marine vessels has
14 increased the size of the City's fleet and caused the cost of supplying said fleet Marine
15 Fuel to exceed \$100,000 per year; and

16 WHEREAS, The Bolder Group, Inc. is currently under Lease Agreement
17 No. 28350 with the Department of Parks, Recreation and Marine to manage the fuel docs
18 at Alamitos Bay and Shoreline Marina; and

19 WHEREAS, The Bolder Group, Inc. provides marine fuel to the public and
20 manages the docks owned by the City; and

21 WHEREAS, it would not be economically beneficial to the City of Long
22 Beach to divide the fuel tanks located at the docks between the public and City users;
23 and

24 WHEREAS, therefore, the Department of Financial Management would like
25 to enter into an annual contract to purchase marine fuel from The Bolder Group, Inc. to
26 simplify fuel delivery and management of fuel operations at the fuel docks;

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
28 follows:

Section 1. The City Manager is hereby authorized to enter into a contract, without advertising for bids, with The Bolder Group, Inc. for the purchase of marine fuel as may be required by the City for a period of one (1) year in an annual amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000) and an additional 10 percent (10%) contingency in the amount of Fifteen Thousand Dollars (\$15,000) for a total annual amount not to exceed \$165,000. The parties may, by mutual agreement, extend the term for three (3) additional periods of one (1) year each.

Section 2. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
