

1 SIXTH AMENDMENT TO AGREEMENT NO. 33453

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 33453 is made and
4 entered, in duplicate, as of May 29, 2019, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on May 7, 2019,
6 by and between BUNNELL ENTERPRISES, INC. DBA TOTAL NETWORK SOLUTIONS,
7 a California corporation, located at 5150 E. Pacific Coast Highway, Suite 530, Long Beach,
8 CA 90804 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills on an
10 as-needed basis in connection with professional and technical services for information
11 technology projects and systems; and

12 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
13 33453 (the "Agreement") whereby Contractor agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to
15 increase the total not to exceed amount to \$150,000; and

16 WHEREAS, the Parties entered into a Second Amendment to the Agreement
17 to extend the term and increase the total not to exceed amount to \$350,000; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to increase the total not to exceed amount to \$500,000; and

20 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
21 to extend the term and increase the total not to exceed amount to \$700,000; and

22 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
23 increase the total not to exceed amount to \$800,000 and extend the term to January 22,
24 2019; and

25 WHEREAS, the Parties desire to add \$100,000 for a total not to exceed
26 amount of \$900,000 and extend the term to October 22, 2019;

27 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
28 conditions herein contained, the Parties agree as follows:

- 1 1. Section 1.A of the Agreement is hereby amended to read as follows:
- 2 “A. Contractor shall furnish specialized services more particularly
- 3 described in Exhibit “A”, attached to the Agreement and incorporated by this
- 4 reference, in accordance with the standards of the profession, and City shall pay
- 5 for these services in the manner described below, a total not to exceed contract
- 6 amount of Nine Hundred Thousand Dollars (\$900,000), at the rates or charges
- 7 shown in Exhibit “A”.”
- 8 2. Section 2 of the Agreement is hereby amended to read as follows:
- 9 “2. TERM. The term of this Agreement shall commence on April 22, 2014,
- 10 and shall terminate on October 22, 2019, unless sooner terminated as provided in this
- 11 Agreement, or unless the services or the Project is completed sooner.”
- 12 3. Except as expressly modified herein, all of the terms and conditions
- 13 contained in Agreement No. 33453 are ratified and confirmed and shall remain in full force
- 14 and effect.
