1 FIRST AMENDMENT TO AGREEMENT NO. 34731

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34731 is made and
4 entered, in duplicate, as of May 18, 2020, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on May 12,
6 2020, by and between AZTECA SYSTEMS, LLC, a Delaware limited liability company
7 ("Consultant"), with a place of business at 11075 South State Street, Suite 24, Sandy, Utah
8 84070, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34731 (the "Agreement") whereby Consultant agreed to provide software licensing,
11 maintenance, and support; and

12 WHEREAS, the Parties desire to increase the annual Agreement amount for
13 the final year of the three-year term;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. For the term of the Agreement ending August 31, 2020 and any
17 authorized extensions, the Agreement amount shall be Sixty Eight Thousand Nine Hundred
18 Ninety-Five Dollars (\$68,995.00) with a ten percent (10%) contingency in the amount of
19 Six Thousand Nine Hundred Dollars (\$6,900.00), for a total not to exceed annual amount
20 of Seventy-Five Thousand Eight Hundred Ninety-Five Dollars (\$75,895.00).

21 2. The term of the Agreement may be extended for two (2) additional
22 one-year periods, at the discretion of the City Manager.

23 3. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 34731 are ratified and confirmed and shall remain in full force
25 and effect.
