

1 FIRST AMENDMENT TO AGREEMENT NO. 35613

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35613 is made and  
4 entered, in duplicate, as of June 22, 2021 for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on May 12,  
6 2020, by and between CORRPRO COMPANIES, INC., an Ohio corporation (“Consultant”),  
7 with a place of business at 10260 Matern Place, Santa Fe Springs, California 90670, and  
8 the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.  
10 35613 (the “Agreement”) whereby Consultant agreed to provide as-needed on-call  
11 professional engineering and inspection services; and

12 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
13 period;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions herein contained, the Parties agree as follows:

16 1. Section 2 of the Agreement is hereby amended to read as follows:

17 “2. TERM. The term of this Agreement shall commence at midnight on  
18 July 1, 2020, and shall terminate at 11:59 p.m. on June 30, 2022, unless sooner terminated  
19 as provided in this Agreement, or unless the services or the Project is completed sooner.  
20 The term may be extended for three (3) additional one-year periods, at the discretion of  
21 the City Manager.”

22 2. Except as expressly modified herein, all of the terms and conditions  
23 contained in Agreement No. 35613 are ratified and confirmed and shall remain in full force  
24 and effect.

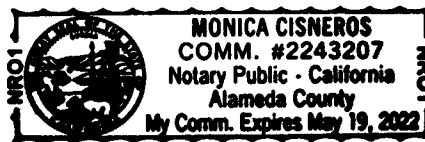
