

1 FIRST AMENDMENT TO AGREEMENT NO. 34549

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34549 is made and
4 entered, in duplicate, as of March 20, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 10, 2017, by and between MIGHTY TRANSPORT, INC. DBA FRANK SCOTTO
7 TOWING, a California corporation ("Contractor"), with a place of business at 1750 W.
8 223RD ST., TORRANCE, CA 90501, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with As Needed Towing Services ("Project"); and

12 WHEREAS, the parties entered Agreement No. 34549 whereby Contractor
13 agreed to provide these services; and

14 WHEREAS, the parties desire to extend the term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 2. Of Agreement No. 34549 is hereby amended to read as
18 follows:

19 "2. TERM. The term of this Agreement shall commence at
20 midnight on May 1, 2016, and shall terminate at 11:59 p.m. on April 30, 2019, unless
21 sooner terminated as provided in this Agreement, or unless the services or the Project is
22 completed sooner. The parties have the option to extend the term for one (1) additional
23 one-year period."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 34549 are ratified and confirmed and shall remain in full
26 force and effect.
