A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH, CALIFORNIA, AUTHORIZING CERTAIN CITY OFFICIALS TO EXECUTE DOCUMENTS PERTAINING TO FINANCIAL ASSISTANCE FOR COSTS INCURRED FOR DECLARED DISASTERS BY THE STATE AND FEDERAL GOVERNMENTS

WHEREAS, the City Council of the City of Long Beach, California, desires to designate and authorize certain City officials to execute documents pertaining to financial assistance for designated emergencies;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the officials employed in the named positions are hereby authorized to execute for and in behalf of the City of Long Beach, California, a public entity established under the laws of the State of California, applications and other documents to be filed in the California Office of Emergency Services and the Federal Emergency Management Agency for the purpose of obtaining certain federal financial assistance under P. L. 93-288, as amended, by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, or state financial assistance under the National Disaster Assistance Act, for costs incurred for declared disasters in 1998 and afterwards:
