3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH, CALIFORNIA, AUTHORIZING  
5 CERTAIN CITY OFFICIALS TO EXECUTE DOCUMENTS  
6 PERTAINING TO FINANCIAL ASSISTANCE FOR COSTS  
7 INCURRED FOR DECLARED DISASTERS BY THE STATE  
8 AND FEDERAL GOVERNMENTS

10 WHEREAS, the City Council of the City of Long Beach, California, desires  
11 to designate and authorize certain City officials to execute documents pertaining to  
12 financial assistance for designated emergencies;

13 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
14 follows:

15 Section 1. That the officials employed in the named positions are hereby  
16 authorized to execute for and in behalf of the City of Long Beach, California, a public  
17 entity established under the laws of the State of California, applications and other  
18 documents to be filed in the California Office of Emergency Services and the Federal  
19 Emergency Management Agency for the purpose of obtaining certain federal financial  
20 assistance under P. L. 93-288, as amended, by the Robert T. Stafford Disaster Relief and  
21 Emergency Assistance Act of 1988, or state financial assistance under the National  
22 Disaster Assistance Act, for costs incurred for declared disasters in 1998 and afterwards:


Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
