3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH, CALIFORNIA, GRANTING
5 PERMISSION TO MEMBERS OF THE PUBLIC TO PARK
6 IN THE AQUARIUM PARKING STRUCTURE AND TO
7 REVISE FEES WITH RESPECT THERETO

9 WHEREAS, on April 28, 1998, the City Council adopted Resolution No.
10 C-27330, which granted permission to the public to park in the Aquarium Parking
11 Structure (formerly known as the Queensway Bay Parking Structure) and setting fees
12 therefor; and

13 WHEREAS, on August 25, 1998, the City Council amended such fees by
14 Resolution No. C-27400; and

15 WHEREAS, on May 4, 1999, the City Council amended such fees by
16 Resolution No. C-27515; and

17 WHEREAS, on November 9, 1999, the City Council amended such fees by
18 Resolution No. C-27612; and

19 WHEREAS, the City Council desires to further amend such fees;

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
21 follows:

22 Section 1. Any person may park a vehicle in the Aquarium Parking
23 Structure subject to the following fee schedule attached as Exhibit "A".

24 Section 2. Resolution No. C-27612 is hereby repealed.

25 Section 3. This resolution shall take effect immediately upon its adoption
26 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


