1 FIRST AMENDMENT TO AGREEMENT NO. 29297

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29297 is made and  
4 entered, in duplicate, as of October 3, 2008 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 September 23, 2008, by and between the LONG BEACH PUBLIC TRANSPORTATION  
7 COMPANY, a California nonprofit corporation ("Long Beach Transit"), whose address is  
8 1963 East Anaheim Street, Long Beach, California 90813, and the CITY OF LONG  
9 BEACH, a municipal corporation ("City").

10 WHEREAS, the parties entered Agreement No. 29297 whereby Long  
11 Beach Transit agreed to provide public transportation services in the City and in  
12 surrounding communities; and

13 WHEREAS, the parties desire to amend Agreement No. 29297 to  
14 accommodate Long Beach Transit's standard operating procedures;

15 NOW, THEREFORE, in consideration of the mutual terms and conditions  
16 contained in Agreement No. 29297 and herein, the parties agree as follows:

17 1. Section 2 of Agreement No. 29297 is hereby amended in its entirety  
18 to read as follows:

19 "2. Long Beach Transit shall prepare and submit a proposed  
20 operating and capital improvement budget for Long Beach Transit's next  
21 succeeding fiscal year to the City's City Manager with a copy to the Director  
22 by May 30 each year. The City Manager will transmit it, with his comments,  
23 to the City Council. Long Beach Transit's budget shall not become effective  
24 until the City Council has had thirty (30) days in which to review and comment  
25 on the budget."

26 2. Except as expressly modified herein, all of the terms and conditions  
27 contained in Agreement No. 29297 are ratified and confirmed and shall remain in full  
28 force and effect.
