FOURTH AMENDMENT TO AGREEMENT NO. 35502

35502

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35502 is made and entered, in duplicate, as of March 29, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 4, 2020, by and between SHREE GANESH, INC., a California corporation ("Contractor"), with a place of business at 802 E. Pacific Coast Highway, Long Beach, CA 90806, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with providing temporary lodging services for human and social services programs in the Department of Health and Human Services; and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35502 (the "Agreement") whereby Contractor agreed to provide the specialized services as described in Request for Proposals No. HE19-131 for Temporary Lodging Services in an amount not to exceed \$300,000.00; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term; and

WHEREAS, approximately on September 30, 2021, City paid contractor an additional \$350,000 for services under the contract; and

WHEREAS, the Parties entered into a Second Amendment to increase the contract amount by an additional \$300,000, for a total not to exceed \$1,000,000.00;

WHEREAS, the Parties entered into a Third Amendment to increase the contract amount to One Million Seven Hundred Fifty Thousand Dollars (\$1,750,000) and extend the term for an additional one (1) year period; and

WHEREAS, the Parties currently desire to enter into a Fourth Amendment to increase the contract amount to Two Million Seven Hundred Seventy-Eight Thousand Seven Hundred Eighty-Five Dollars (\$2,778,785);

NOW, THEREFORE, in consideration of the mutual terms, covenants, and

1 conditions herein contained, the Parties agree as follows:

2 1. Section 1.A. of the Agreement is hereby amended to read as follows:

3 "A. Contractor shall furnish specialized services more particularly
4 described in Contractor's Response to RFP, attached hereto as Exhibit "A" and
5 incorporated by this reference, in accordance with the standards of the profession, and city
6 shall pay for these services in the manner described below, in an aggregate contract
7 amount not to exceed Two Million Seven Hundred Seventy-Eight Thousand Seven
8 Hundred Eighty-Five Dollars (\$2,778,785), at the rates or charges shown in Exhibit "B"."

9 2. Except as expressly modified herein, all of the terms and conditions
10 contained in this Agreement are ratified and confirmed and shall remain in full force and
11 effect.
