

PETITION FOR CLASS 2 EBIKES TO HAVE ACCESS TO THE LONG BEACH BIKE PATH

This Petition is prepared on behalf of Class 2 EBike owners that request continued access to the Long Beach Bike path. During this time of creating new rules and regulations for our safety, we provide you with a brief list of reasons why our EBikes are beneficial to us and our Community. The majority of EBike owners are baby boomers and use the EBikes to go longer distances, use for physical and mental therapy, as well as social gatherings and commuting. Many of us go on group rides on the weekends to restaurants, parks, errands, etc. This cuts down on traffic, parking issues, pollution, costs and all the stresses of driving a car. If it wasn't for the Class 2 EBike, there are a portion of people who would never get outside and enjoy life the way they do now. The bikes only go 20 miles an hour maximum and everyone rides with extreme caution and safety. We, the undersigned, Petition for Class 2 EBikes to the Long Beach bike path which provides us safety and enjoyment of our beautiful Community.

If you want to police something make sure that the bikes that you allow are Class one and two. There is no difference between the two other than they way the motor is controlled. They both have pedals and class one are more advanced and more expensive and will be the future. But for now a large percentage of e-bike are class 2 because of the higher cost of the on board computer and torque sensor vs cadence sensor at the time they were made. . Banning class 2 e-bikes signals that someone does not understand the difference between class one and two. They both have the same 750 watt power limit and 20 MPH speed limiter before assist cuts off. There is no difference. They both have pedals. Class one has a cruse control when pedaled and class to is controlled by the rider regardless if the pedals are |
