AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY ADDING SECTION 2.07.020 OF THE LONG BEACH MUNICIPAL CODE REGARDING ETHICS TRAINING FOR MEMBERS OF BOARDS, **COMMISSIONS AND COMMITTEES**

WHEREAS, the California State Legislature has enacted California Government Code Section 53234 (AB 1234), which mandates ethics training by all local elected officials and members of boards, commissions or committees which receive compensation or reimbursement for expenses; and

WHEREAS, the City Council desires to amend the Long Beach Municipal Code in order to incorporate this requirement into the regulations applicable to all boards, commissions and committees;

NOW, THEREFORE, the City Council ordains as follows:

Section 1. Section 2.07.020 of the Long Beach Municipal Code is hereby added to read as follows:

2.07.020 Required ethics training.

In the event that a member of any City Charter commission or advisory body fails to complete the ethics training required by California Government Section 53234 et seg., within the time period specified therein, that person shall automatically be removed from membership from said commission or advisory body.
