ORDINANCE NO. ORD-14-0005

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY ADDING SUBSECTION 5.48.010.F
RELATING TO HOTEL AND MOTEL RENTALS;
DECLARING THE URGENCY THEREOF; AND
DECLARING THAT THIS ORDINANCE SHALL TAKE
EFFECT IMMEDIATELY

The City Council of the City of Long Beach ordains as follows:

Section 1. Subsection 5.48.010.F is added to the Long Beach Municipal
Code to read as follows:

F. Right to Judicial Review.

If permission to inspect is refused or cannot be obtained, a valid
court order for inspection shall be obtained from a court of competent
jurisdiction upon a showing of probable cause to believe that a violation of this
Chapter may exist.

Section 2. Declaration of Urgency. This ordinance is an emergency
measure, and it is urgently required in order to bring the City's Municipal Code into
compliance with the ruling of the Ninth Circuit Court of Appeal in *Patel v. City of Long
Beach* (No. 09-56099; DC No. 2:08-cv-02806-ABC-VBK).

Section 3. This ordinance is an emergency ordinance duly adopted by
the City Council on May 20, 2014, by a vote of at least five (5) of its
members and shall take effect immediately. The City Clerk shall certify to a separate roll

1 call and vote on the question of the emergency of this ordinance and to its passage by
2 the vote of five (5) members of the City Council of the City of Long Beach, and cause the
3 same to be posted in three conspicuous places in the City of Long Beach.

5 Section 4. This ordinance shall also be adopted by the City Council as a
6 regular ordinance, to the end that in the event of any defect or invalidity in connection
7 with the adoption of this ordinance as an emergency ordinance, the same shall,
8 nevertheless, be and become effective on the thirty-first day after it is approved by the
9 Mayor.

10 I hereby certify that on a separate roll call and vote which was taken by the
11 City Council of the City of Long Beach upon the question of emergency of this ordinance
12 at its meeting of May 20, 2014, the ordinance was declared to be an
13 emergency by the following vote:






