SECOND AMENDMENT TO AGREEMENT NO. 35262

THIS SECOND AMENDMENT TO AGREEMENT NO. 35262 is made and entered, as of April 18, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 5, 2019, by and between NANCY K. BOHL, INC. dba THE COUNSELING TEAM INTERNATIONAL, a California corporation ("Consultant"), with a place of business at P.O. Box 10427, San Bernardino, California 92423, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35262 (the "Agreement") whereby Consultant agreed to provide critical incident and counselling services for public safety personnel within the Police Department for a period of one (1) year with the option to renew for four (4) additional one-year periods, at the discretion of the City Manager, for a total annual amount not to exceed \$117,000; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to April 30, 2023; and

WHEREAS, the Parties desire to utilize their final option to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:
"2. TERM. The term of this Agreement shall commence at midnight on June 1, 2020 and shall terminate on April 30, 2024."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35262 are ratified and confirmed and shall remain in full force and effect.
