SECOND AMENDMENT TO AGREEMENT NO. 34160

THIS SECOND AMENDMENT TO AGREEMENT NO. 34160 is made and entered, in duplicate, as of August 23, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 20, 2017, by and between MARYAM A. ABDELNABY, M.D., INC., a California corporation ("Contractor"), with a place of business at 2563 Plaza Del Amo #406, Torrance, California 90503, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with Jail Inmate Medical Services ("Project"); and

WHEREAS, the parties entered Agreement No. 34160 whereby Contractor agreed to provide these services; and

WHEREAS, the parties desire to extend the Contract term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 2. Of Agreement No. 34160 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on September 1, 2015, and shall terminate at 11:59 p.m. on September 1, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34160 are ratified and confirmed and shall remain in full force and effect.
