ORDINANCE NO. ORD-22-0025

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH SETTING ASIDE AND DEDICATING
IN PERPETUITY CERTAIN LANDS OWNED BY THE CITY OF
LONG BEACH FOR PUBLIC PARK PURPOSES AND USES

WHEREAS, on November 18, 2021, the Parks and Recreation Commission recommended the designation or dedication of Tanaka Park.

WHEREAS, the Planning Commission, at its hearing on July 8, 2022, recommended to the City Council the approval of the dedication in perpetuity and associated land use actions of Tanaka Park.

WHEREAS, the City Council hereby finds this action is categorically exempt under the California Environmental Quality Act (CEQA) and finds that the proposed dedication in perpetuity of Tanaka Park will not categorically affect the character, livability or appropriate development of the surrounding properties and that the proposed amendments are consistent with the goals, objectives and provisions of the General Plan, including the Land Use Element, and the Open Space and Recreation Element thereof.

NOW, THEREFORE, The City Council of the City of Long Beach ordains as follows:

Section 1. Park Dedication.

In accordance with the goals, objectives, policies and programs of the Land Use Element, and the Open Space and Recreation Element of the General Plan of the City of Long Beach, the following areas of the City are hereby set aside and dedicated in perpetuity for public park purposes:
