Section 1. The City Council of the City of Long Beach shall be the administering agency and signatory authority for the Program.

Sec. 2. The City Council of the City of Long Beach designates the Greater Long Beach Workforce Development Board to provide policy guidance and oversight for the Program.

Sec. 3. The City Council of the City of Long Beach acknowledges that the City shall be responsible to the State of California, Employment Development Department, for the expenditure of all funds and liable for those funds not expended in
