THIS FOURTH AMENDMENT TO AGREEMENT NO. 29697 is made and entered, in duplicate, as of March 20, 2009 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on June 19, 2007, by and between UNITED STORM WATER, INC., a California corporation, whose address is 14000 East Valley Boulevard, City of Industry, California 91746 ("Contractor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 29697 whereby Contractor agreed to provide specialized services requiring unique skills to be performed in connection with the Municipal Separate Storm Drain System Maintenance and Repair Services ("Project"); and

WHEREAS, the First Amendment to Agreement No. 29697 extended the term and increased the amount of said Agreement; and

WHEREAS, the Second Amendment to Agreement No. 29697 again extended the term of said Agreement; and

WHEREAS, the Third Amendment to Agreement No. 29697 increased the amount of said Agreement; and

WHEREAS, the parties desire to increase the Agreement by \$570,000 for a total not to exceed amount of \$1,570,000.00;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein, the parties agree as follows:

1. Except as expressly amended herein, all terms and conditions in Agreement No. 29697 are ratified and confirmed and shall remain in full force and effect.
