WHEREAS, the City requires polygraph testing services and analysis requiring unique skills to be performed in connection with pre-employment background checks and other law enforcement activities; and

WHEREAS, in May of 2006, City and Consultant entered into Agreement No. 29930 for Consultant to provide City with polygraph testing services; and

WHEREAS, on June 15, 2007 the parties executed a First Amendment to extend the term; and

WHEREAS, City desires to exercise its second option and extend the term of the Agreement for an additional year;

NOW THEREFORE, in consideration of the mutual terms and conditions in Agreement No. 29930, the parties agree as follows:

Section 2 of the Agreement is deleted in its entirety and amended to read:

"2. TERM. The term of this Agreement shall commence at midnight on May 11, 2008 and shall terminate at 11:59 p.m. on May 10, 2009, unless sooner terminated as provided in this Agreement."

Except as expressly amended herein, all of the terms and conditions in Agreement No. 29930 are ratified and confirmed and shall remain in full force and effect.
