

1 FIRST AMENDMENT TO AGREEMENT NO. 34499

2 34499

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34499 is made and
4 entered, in duplicate, as of March 20, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 10, 2017, by and between A & A TOWING, INC., a California corporation
7 ("Contractor"), with a place of business at 3204 CHERRY AVE., LONG BEACH, CA
8 90807, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with As Needed Towing Services ("Project"); and

11 WHEREAS, the parties entered Agreement No. 34499 whereby Contractor
12 agreed to provide these services; and

13 WHEREAS, the parties desire to extend the term and add the annual
14 amount of \$50,000 for a total not to exceed contract amount of \$140,000;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 1.A. of Agreement No. 34499 is hereby amended to read as
18 follows:

19 "A. Contractor shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this
21 reference, in accordance with the standards of the profession and the terms and
22 conditions stated herein, and City shall pay for these services in the manner
23 described below, not to exceed Ninety Thousand Dollars (\$90,000) annually for
24 the period of May 1, 2016 through April 30, 2018, and the amount not to exceed
25 Fifty Thousand Dollars (\$50,000) annually for the period of May 1, 2018 through
26 April 30, 2019, at the rates or charges shown in Exhibit "B"."

27 2. Section 2. Of Agreement No. 34499 is hereby amended to read as
28 follows:

1 "2. TERM. The term of this Agreement shall commence at
2 midnight on May 1, 2016, and shall terminate at 11:59 p.m. on April 30, 2019, unless
3 sooner terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner. The parties have the option to extend the term for one (1) additional
5 one-year period."

6 3. Except as expressly modified herein, all of the terms and conditions
7 contained in Agreement No. 34499 are ratified and confirmed and shall remain in full
8 force and effect.

9 IN WITNESS WHEREOF, the parties have caused this document to be duly
10 executed with all formalities required by law as of the date first stated above.
