3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH THE
6 GORDIAN GROUP, INC. DBA THE MELLON GROUP IN
7 AN AMOUNT NOT TO EXCEED \$292,500 TO PURCHASE
8 PRO-GEN SOFTWARE AND ADMINISTRATIVE
9 SERVICES TO MANAGE THE JOC PROGRAM, THROUGH
10 THE AGREEMENT BETWEEN THE CALIFORNIA STATE
11 UNIVERSITY AND THE GORDIAN GROUP, INC. DBA THE
12 MELLON GROUP

14 WHEREAS, the Charter of the City of Long Beach (the "City"), Section
15 1802, permits the City to purchase services, supplies, materials, equipment and labor
16 with other government agencies by purchasing under their contracts on a voluntary and
17 selective basis when authorized by resolution; and

18 WHEREAS, the City desires to purchase software and the necessary
19 support services that allow Job Order Contract ("JOC") contractors to produce the
20 detailed construction proposals for City consideration; and

21 WHEREAS, California State University ("CSU") has an Agreement with The
22 Gordian Group, Inc. dba The Mellon Group for a Systemwide Job Order Contract
23 System, Agreement No. 80246 ("CSU Contract"); and

24 WHEREAS, the City's participation in the CSU Contract will facilitate
25 expeditious completion of a Systemwide Job Order Contract System as well as provide
26 considerable cost benefits to the City; and

27 WHEREAS, if the City had to go to formal bid rather than participate in the
28 CSU Contract considerably more funds would be required;

1 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
2 follows:

3 Section 1. The above recitals are true and correct and are incorporated
4 herein by this reference.

5 Section 2. The City Manager of the City of Long Beach is hereby
6 authorized to enter into an agreement with The Gordian Group, Inc. dba The Mellon
7 Group in an amount not to exceed \$292,500 for three years with the option of renewing
8 for two additional one-year periods for a Systemwide Job Order Contract System, on
9 substantially the same terms and conditions afforded to CSU.

10 Section 3. This resolution shall take effect immediately upon its adoption
11 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

12 I hereby certify that the foregoing resolution was adopted by the City
13 Council of the City of Long Beach at its meeting of September 18, 2012 by the
