

1 THIRD AMENDMENT TO CONTRACT NO. 33664

3 THIS THIRD AMENDMENT TO CONTRACT NO. 33664 is made and
4 entered, in duplicate, as of January 6, 2020, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 3, 2019, by and between FERGUSON ENTERPRISES, LLC, a Virginia limited
7 liability company, formerly known as FERGUSON ENTERPRISES, INC. a Virginia
8 corporation ("Contractor"), whose address is 12500 Jefferson Avenue, Newport News,
9 Virginia 23602, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 33664 (the "Contract") whereby Contractor agreed to provide as-needed plumbing
12 supplies; and

13 WHEREAS, the Parties entered into a First Amendment to the Contract to
14 extend the term to January 25, 2018 and add \$910,000 for a total not to exceed amount of
15 \$2,730,000; and

16 WHEREAS, the Parties entered into a Second Amendment to the Contract
17 to extend the term to January 25, 2019 and attach an updated rate sheet; and

18 WHEREAS, the Parties desire to extend the term and add \$300,000 to the
19 Contract to allow for the completion of a new procurement process;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions herein contained, the Parties agree as follows:

22 1. The extended term of this Contract shall commence at midnight on
23 January 26, 2019, and shall terminate at 11:59 p.m. on April 30, 2020, unless sooner
24 terminated as provided in this Contract, or unless the services or the Project is completed
25 sooner.

26 2. Three Hundred Thousand Dollars (\$300,000) is hereby added to the
27 Contract extension terminating on April 30, 2020.

28 3. Except as expressly amended herein, all terms and conditions in
