THIS FIRST AMENDMENT TO AGREEMENT NO. 33262 is made and entered, in duplicate, as of March 25, 2015, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 9, 2013, by and between ZONAR SYSTEMS, INC., a Washington corporation ("Zonar"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Zonar entered into a Global Positioning System ("GPS") Services Agreement dated October 1, 2013 (the "Agreement"); and

WHEREAS, City and Zonar now desire to amend the Agreement to reflect City's exercise of its first option to extend the term of the Agreement for one (1) additional year;

NOW, THEREFORE, in consideration of the terms and conditions contained herein, the City and Zonar agree as follows:

1. This Amendment shall be effective as of the date on which this Amendment is executed by both parties (the "Effective Date").
2. Pursuant to the exercise of City's option to extend the term of the Agreement under Section 3 of the Agreement, the term of the Agreement shall expire on July 21, 2016. City has one (1) additional remaining option under Section 3 of the Agreement to extend the term.
3. Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 33262 are ratified and confirmed and shall remain in full force and effect.
