Paul Getty Trust (the Information "Trust") and of the Trust's acceptance of Transferor's transfer of the Property (subject to the terms set out below), do hereby irrevocably and unconditionally transfer, assign, convey and deliver, together with all copyright, trademark and related interests of Transferors therein, and all goodwill associated therewith, to the Trust, to become its property, the following (the "Property"): The complete Long Beach Museum of Art Video Archive as of August 2005 as well as documentation of the archive, video exhibitions, and programs held at the Long Beach Museum of Art. A complete inventory will be prepared by the Trust after delivery of the archive to the Trust, and a copy will be given to the Long Beach Museum of Art and to the City of Long Beach. The inventory shall also be attached by the Trust to this Agreement as Exhibit "A." The Property has been delivered to the Trust on (date) ansferor or Transferor's Authorized Representative RATU of Transferor or Transferor's Authorized Representative larrow Interim Hesident and CEO

The Trust has accepted the Property listed above, subject to the following terms:

1. By execution of this Agreement, Transferors expressly represent and warrant to the Trust that they are the sole lawful owners of title of the Property or that Transferors are fully authorized by such owners to enter into this Agreement. Transferors further represent that the Property is free and clear from any and all encumbrances, that there has been no prior pledge, option or gift of any part thereof granted to any person, that Transferors have the right to give or sell the Property, and that Transferors will warrant and defend the title thereto against lawful claims and demands of all persons.

2. Transferors shall deliver the Property to the Trust at a mutually agreed place and time. Transferors acknowledge that, upon transfer, the Property irrevocably becomes the property of the Trust. The Trust may display, perform, store, maintain and dispose of the Property without restriction (subject to Section 8, below). The Trust has not promised and is in no way obligated to exhibit or perform the Property. As consideration for the transfer of the Property, the Trust shall provide to Transferors the following consideration subject to available resources, applicable law, including

without limitation copyright law, and the acquisition of the necessary rights, if any, all as determined by the Trust:

- a. Transportation, inventory, cataloging and conservation of the Property. The Trust shall provide Transferors with a complete inventory of the Property. The Trust shall also attach the inventory to this Agreement as Exhibit "A";
- b. A digital copy of any video that the Trust reformats from the material described above and defined as Property. The Trust shall not be required to provide a digital copy of the records and documents that pertain to the video material and which are also included in the definition of Property. The Trust is not required to obtain any rights for the exhibition, performance, reproduction or distribution of the Property. Any use of the digital copies of the Property provided by the Trust to the Transferors shall be undertaken at the sole cost, expense and liability of Transferors. Transferors shall indemnify and hold harmless the Trust from any and all claims relating to such use(s) by Transferors;
- c. An equal share in any profits generated by the Trust as a result of the Commercial Use of the Property. The Trust shall notify Transferors of such Commercial Use activities and shall account for profits at reasonable intervals. The Trust shall account for profits at least once per year. The Trust shall have no obligation to exploit the Property for any Commercial Use. Commercial Use shall mean any activity from which the revenues generated exceed the expenditures of the activity and the costs incurred by the Trust of maintaining the Property. Use of the Property in mission-related, non-profit activities that result in a profit shall not be considered a Commercial Use.
- 3. The Trust shall consult with and provide the opportunity for review and comment to Transferors prior to the issuance of the first press release regarding the transfer of the Property. Thereafter the Trust shall not be required to seek Transferors' input on any subsequent press release although nothing contained herein shall preclude the Trust from doing so.
- 4. Transferors represent and warrant that no customs laws, tax laws, laws of inheritance, or other laws or regulations applicable to the Property, its export or import, have been broken.
- 5. Transferors represent and warrant that to the best of their knowledge there are no claims, judgments, liens or other encumbrances of any kind whatsoever against the Property, any portion of the Property, or title to it.
- 6. Transferors will defend, indemnify and hold the Trust harmless from claims or allegations arising from or relating to conduct that would be a breach of Transferor's warranties or representations herein, including, without limitation, any use by Transferors or a third party who obtained the Property

from Transferors, directly or indirectly, of the copies of the Property provided to Transferors by the Trust in accordance with Section 2(b), above.

- 7. The Trust will include the following credit in connection with the Property: "Long Beach Museum of Art Video Archive, Research Library at the Getty Research Institute. Transferred by the Long Beach Museum of Art Foundation and the City of Long Beach, 2005." Transferors shall not use the names "The J. Paul Getty Trust" or "Getty" (alone or as part of another name), or the names of Trust employees, trustees, or agents, for any purpose, including, but not limited to, advertising and marketing, except with advance written permission from the Trust. Transferors consent to the use of their names by the Trust in connection with the Trust's use or promotion of the Property, or any portion thereof.
- 8. The Trust agrees that if, in its sole and absolute discretion, it decides to deaccession any or all of the Property, it will first offer the Property to City at no cost to City. City shall have sixty (60) days to either accept the transfer of the Property or decline the transfer. If City does not accept the transfer of the Property, then the Trust shall offer the Property to Museum, at no cost to Museum. Museum shall have sixty (60) days to either accept the transfer of the Property or decline the transfer. If Museum does not accept the transfer of the Property, the Trust shall be free to dispose of the Property, in whole or in part, without any further restrictions, obligations or considerations to either the City or the Museum.
- 9. This Agreement is governed by the law of the State of California. All litigation arising from or relating to this Agreement will be prosecuted in any court of competent subject matter jurisdiction in Los Angeles, California, and Transferors consent to the jurisdiction of such courts.
