3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH DECLARING THE RESULTS OF
5 THE GENERAL MUNICIPAL ELECTION HELD IN THE
6 CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY,
7 NOVEMBER 8, 2022, FOR THE PURPOSE OF ELECTING
8 A MAYOR, MEMBERS OF THE CITY COUNCIL FROM
9 THE THIRD, FIFTH AND NINTH COUNCIL; LONG BEACH
10 UNIFIED SCHOOL DISTRICT GOVERNING BOARD
11 MEMBER, DISTRICT NUMBER 1; AND DIRECTING THE
12 CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION
13 TO THE CANDIDATES DECLARED TO HAVE BEEN
14 ELECTED AT THE GENERAL MUNICIPAL ELECTION

16 WHEREAS, the City Council of the City of Long Beach did, by Resolutions
17 Nos. RES-22-0017, RES-22-0018, RES-22-0019 AND RES-22-0110, duly call and provide
18 for the holding of a General Municipal Election on Tuesday, November 8, 2022, for the
19 purpose of electing a Mayor; three (3) offices on the City Council from Districts 3, 5 and 9;
20 and one (1) Long Beach Unified School District Governing Board Member, District Number
21 1; and

22 WHEREAS, the General Municipal Election was held in the City of Long
23 Beach on Tuesday, November 8, 2022; and

24 WHEREAS, the Los Angeles County Registrar duly canvassed the returns of
25 the election and has transmitted the results to the City Clerk;

26 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
27 follows:

28 Section 1. A true and correct copy of the canvass of the votes cast in for

1 Mayor, Council Districts 3, 5 and 9; Long Beach Unified School District Governing Board
2 Member, District Number 1; attached as Exhibit "A" to the Resolution.

3 Section 2. That the candidates nominated as required by law for the
4 Office of the Mayor, and the names of the persons voted for at the election, were:

5 Rex Richardson

6 Suzie Price

7 That Rex Richardson received a majority of the votes cast for all candidates
8 for the office of Mayor, and Rex Richardson is declared elected to the office of Mayor for
9 the full term of four (4) years commencing with the third Tuesday of December, 2022. The
10 City Clerk is directed to issue Rex Richardson a Certificate of Election certifying to the
11 election to this office for such term.

12 Section 3. That the candidates nominated as required by law for the three
13 (3) offices of Members of the City Council, and the names of the persons voted for at the
14 election were:

15 Third District: Kristina Duggan

16 Kailee Caruso

17 Fifth District: Ian Patton

18 Megan Kerr

19 Ninth District: Joni Ricks-Oddie

20 Ginny Gonzales

21 Section 4. That the candidates nominated as required by law for the one
22 (1) office of Member of the Long Beach Unified School District Governing Board Member,
23 and the names of the persons voted for at the election were:

24 District 1: Maria Isabel Lopez

25 Nubia Flores

26 Section 5. That Kristina Duggan received a majority of the votes cast for
27 all candidates for the office of Member of the City Council from the Third District, and in
28 accordance with the provisions of law governing the nomination and/or election of

1 candidates for this office, Kristina Duggan is declared elected to the office of Member of
2 the City Council from the Third District for the full term of four (4) years commencing with
3 the third Tuesday of December, 2022. The City Clerk is directed to issue Kristina Duggan
4 a Certificate of Election certifying to the election to this office for such term.

5 Section 6. That Megan Kerr received a majority of the votes cast for all
6 candidates for the office of Member of the City Council from the Fifth District, and in
7 accordance with the provisions of law governing the nomination and/or election of
8 candidates for this office, Megan Kerr is declared elected to the office of Member of the
9 City Council from the Fifth District for the full term of four (4) years commencing with the
10 third Tuesday of December, 2022. The City Clerk is directed to issue Megan Kerr a
11 Certificate of Election certifying to the election to this office for such term.

12 Section 7. That Joni Ricks-Oddie received a majority of the votes cast for
13 all candidates for the office of Member of the City Council from the Ninth District, and in
14 accordance with the provisions of law governing the nomination and/or election of
15 candidates for this office, Joni Ricks-Oddie is declared elected to the office of Member of
16 the City Council from the Ninth District for the full term of four (4) years commencing with
17 the third Tuesday of December, 2022. The City Clerk is directed to issue Joni Ricks-Oddie
18 a Certificate of Election certifying to the election to this office for such term.

19 Section 8. That Maria Isabel Lopez received a majority of the votes cast
20 for all candidates for the office of Member of the Board of Education of the Long Beach
21 Unified School District, Number 1, and is declared elected to such office for the full term of
22 four (4) years commencing with the third Tuesday of December, 2022.

23 Section 9. This resolution shall take effect immediately upon its adoption
24 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
