3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH TO TEMPORARILY CLOSE AND  
5 REMOVE FROM PUBLIC USE CERTAIN STREETS,  
6 ALLEYS, AND WALKWAYS IN THE CITY OF LONG BEACH  
7 IN CONNECTION WITH THE CONDUCT OF THE 2021  
8 FORMULA DRIFT PRO CHAMPIONSHIP

10 The City Council of the City of Long Beach resolves as follows:

11 Section 1. The City Council of the City of Long Beach finds and  
12 determines that the temporary closing of the streets, described herein, is necessary for  
13 the safety and protection of the participants and spectators in the 2021 Formula Drift Pro  
14 Championship to be held from September 17, 2021 through September 18, 2021.

15 Section 2. For the conduct of the 2021 Formula Drift Pro Championship,  
16 the following streets, alleys, and walkways are hereby temporarily closed for the periods  
17 stated:

18 A. On September 17, 2021 through September 18, 2021 from  
19 7:00 a.m. to 7:00 p.m., Seaside Way from Pine Avenue to eastern end of  
20 Seaside Way, Linden Avenue from Ocean Boulevard to Seaside Way,  
21 Marine Way from Locust Avenue to Collins Way, Atlantic Way from Ocean  
22 Boulevard to Seaside Way, Marine Way from Hart Place to eastern end,  
23 Linden Avenue, northbound and southbound from Shoreline Drive to Marina  
24 Parking lot, and Locust Avenue from Ocean Boulevard to Seaside Way.

25 B. On September 17, 2021 through September 18, 2021 from  
26 7:00 a.m. to 7:00 p.m., Shoreline Drive westbound from Ocean Boulevard  
27 and Alamitos intersection to Shoreline Village Drive.

28 C. On September 17, 2021 through September 18, 2021 from

1 7:00 a.m. to 7:00 p.m., Shoreline Drive eastbound from Shoreline Village  
2 Drive to Ocean Boulevard and Alamitos intersection.

3 D. On September 17, 2021 through September 18, 2021 from  
4 7:00 a.m. to 7:00 p.m., walkway off of Seaside Way from Hart Place to the  
5 east end of Seaside Way.

6 Section 3. The temporary closing of the above streets, alleys, and  
7 walkways, for the times herein provided is necessary for the safety and protection of the  
8 participants and spectators in the 2021 Formula Drift Pro Championship and qualifying  
9 events to be held from September 17, 2021 through September 18, 2021, utilizing the  
10 streets described herein.

11 Section 4. For the period September 17, 2021 through September 18,  
12 2021 from 7:00 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section  
13 2.A. are hereby withdrawn and removed from public use.

14 Section 5. For the period September 17, 2021 through September 18,  
15 2021 from 7:00 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section  
16 2.B. are hereby withdrawn and removed from public use.

17 Section 6. For the period September 17, 2021 through September 18,  
18 2021 from 7:00 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section  
19 2.C. are hereby withdrawn and removed from public use.

20 Section 7. For the period September 17, 2021 through September 18,  
21 2021 from 7:00 a.m. to 7:00 p.m., the streets, alleys and walkways described in Section  
22 2.D. are hereby withdrawn and removed from public use.

23 Section 8. The City Manager, or his designee, is authorized and directed  
24 to post notices of the intent to temporarily reduce lanes, close the streets, alleys,  
25 walkways described in Sections 2, 3, 4, 5, 6, and 7 above at least twenty-four (24) hours  
26 prior to the closure thereof.

27 Section 9. This resolution shall take effect immediately upon its adoption  
28 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
