

1 FIRST AMENDMENT TO AGREEMENT NO. 34167

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34167 is made and  
4 entered, in duplicate, as of July 19, 2017, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 June 20, 2017, by and between AMERICAN CORRECTIONAL SOLUTIONS, INC., a  
7 California corporation ("Contractor"), with a place of business at 741 E. Ball Road, Ste.  
8 #205, Anaheim, CA 92805, and the CITY OF LONG BEACH, a municipal corporation  
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be  
11 performed in connection with Jail Inmate Medical Services; and

12 WHEREAS, the parties entered Agreement No. 34167 whereby Contractor  
13 agreed to provide these services; and

14 WHEREAS, the parties desire to add the annual amount of \$390,000 for a  
15 total not to exceed contract amount of \$760,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 34167 is hereby amended to read as  
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Contractor shall furnish specialized services more  
22 particularly described in Exhibit "A-2", attached to this Agreement and  
23 incorporated by this reference, in accordance with the standards of the profession,  
24 and City shall pay for these services in the manner described below, not to exceed  
25 Seven Hundred Sixty Thousand Dollars (\$760,000.00), at the rates or charges  
26 shown in Exhibit "A-2".

27 2. Except as expressly modified herein, all of the terms and conditions  
28 contained in Agreement No. 34167 are ratified and confirmed and shall remain in full


