2	THIS THIRD AMENDMENT TO AGREEMENT NO. 29238 ("Amendment") is made
3	and entered, in duplicate, as of March 16, 2007, for reference purposes only, pursuant to a
4	minute order adopted by the City Council of the City of Long Beach at its meeting on
5	December 5, 2006, by and between COMMUNITY HOSPITAL OF LONG BEACH, a public
6	benefit corporation ("Contractor"), and the CITY OF LONG BEACH ("City").
7	WHEREAS, the parties entered Agreement No. 29238 whereby Contractor agreed to
8	provide emergency services with respect to persons booked by the City's Police
9	Department and victims of certain crimes; and
10	WHEREAS, the parties entered into the First Amendment to Agreement No. 29238,
11	dated as of April 20, 2006, which extended the term of the Agreement for an additional
12	year; and
13	WHEREAS, the parties entered into the Second Amendment to Agreement No.
14	29238 on December 13, 2006, which provided the parties with the option of extending the
15	term of the agreement for an additional year;
16	NOW, THEREFORE, in consideration of the mutual terms and conditions in
17	Agreement No. 29238 and herein the parties agree as follows:
18	1. Section 2 of Agreement No. 29238, is hereby amended in its entirety to read as
19	follows:
20	"2. The term of this agreement shall commence on May 1, 2007 and shall
21	terminate at 11:59 p.m. on April 30, 2008.
22	2. Section 4 of Agreement No. 29238 is hereby amended in its entirety to read as
23	follows:
24	"City shall pay Hospital within forty-five (45) days following receipt from Hospital of
25	invoices for these services and for which payment has not previously been made by City to
26	Hospital provided, however, that: (a) Hospital shall submit all invoices within forty-five (45)
27	days after the end of the month in which services were performed and any invoices

1	submitted after such time will not be paid	d; and (b) Hospital shall submit invoices on behalf
2	of and render payment to the physicians	that the Hospital uses to provide medical services
3	under this Agreement, after such medica	al services have been provided hereunder and the
4	City shall have no obligation to pay these	e physicians directly. The total compensation to be
5	paid under this Agreement shall n	ot exceed Four Hundred Thousand Dollars
6	(\$400,000.00)."	
7	3. Except as expressly amended	herein, all terms and conditions in Agreement No.
8	29238 are ratified and confirmed and sh	nall remain in full force and effect.
