3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY TO  
5 EXECUTE AN AGREEMENT TO PURCHASE LOCAL AND  
6 LONG DISTANCE TELEPHONE, DATA COMMUNICATION  
7 AND INTERNET SERVICES THROUGH THE CONTRACTS  
8 BETWEEN VERIZON BUSINESS NETWORK SERVICES  
9 AND THE STATE OF CALIFORNIA

11 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits  
12 the City to participate in joint cooperative purchasing of services, supplies, materials,  
13 equipment, and labor with other government agencies by purchasing under their contracts  
14 on a voluntary and selective basis when authorized by resolution; and

15 WHEREAS, the City of Long Beach desires to purchase local and long  
16 distance telephone, data communication and internet services from Verizon Business  
17 Network Services; and

18 WHEREAS, the State of California has contracts for the purchase of Verizon  
19 Business Network Services known as Price Agreement Nos. 5-06-58-20 (DTS 06E1392)  
20 and 05-06-58-21 (DTS 06E1393) ("Price Contracts"); and

21 WHEREAS, the City's participation in the Price Contracts will facilitate  
22 acquisition of local and long distance telephone, data communication and internet  
23 services, as well as provide considerable cost benefits to the City; and

24 WHEREAS, if the City had to go to formal bid rather than participate in the  
25 Price Contracts, considerably more funds would be required;

26 NOW, THEREFORE, the City of Long Beach resolves as follows:

27 Section 1. The above recitals are true and correct and are incorporated  
28 herein by this reference.

1 Section 2. The City Manager of the City of Long Beach is hereby  
2 authorized to enter into an agreement with Verizon Business Network Services for the  
3 purchase of local and long distance telephone, data communication and internet services  
4 as ordered by the City of Long Beach, pursuant to the Price Contracts. The purchase by  
5 the City of Long Beach shall be on the same terms and conditions afforded to the State,  
6 in an amount not to exceed One Million Four Hundred Seventy Thousand Seven  
7 Hundred Dollars (\$1,470,700.00) for a period of three (3) years with options for two (2)  
8 additional periods of one (1) year each.

9 Section 3. This resolution shall take effect immediately upon its adoption  
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

11 I hereby certify that the foregoing resolution was adopted by the City  
12 Council of the City of Long Beach at its meeting of July 23, 2013 by the
