1 FIRST AMENDMENT TO AGREEMENT NO. 33819

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33819 is made and
4 entered, in duplicate, as of October 1, 2015, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 January 6, 2015, by and between INTERWEST CONSULTING GROUP, a California
7 corporation ("Consultant"), with a place of business at 15061 Springdale Street, Suite
8 205, Huntington Beach, California 92649, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed plan review and inspection services; and

12 WHEREAS, the parties entered Agreement No. 33819 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to increase the amount of the first year of the
15 Agreement by \$60,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions in this Agreement, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 33819 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, an amount not to exceed Ninety
25 Thousand Dollars (\$90,000) for the first year of the Agreement, ending January 6,
26 2016. City shall pay Consultant an annual amount not to exceed Thirty Thousand
27 Dollars (\$30,000), at the rates or charges shown in Exhibit "B", for the duration of
28 the Agreement, including any extensions or renewals."

1 2. Except as expressly modified herein, all of the terms and conditions
2 contained in Agreement No. 33819 are ratified and confirmed and shall remain in full
3 force and effect.

4 IN WITNESS WHEREOF, the parties have caused this document to be duly
5 executed with all formalities required by law as of the date first stated above.
