THIS FIRST AMENDMENT TO AGREEMENT NO. 33819 is made and entered, in duplicate, as of October 1, 2015, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 6, 2015, by and between INTERWEST CONSULTING GROUP, a California corporation ("Consultant"), with a place of business at 15061 Springdale Street, Suite 205, Huntington Beach, California 92649, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, the parties entered Agreement No. 33819 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to increase the amount of the first year of the Agreement by \$60,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 1.A. of Agreement No. 33819 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, an amount not to exceed Ninety Thousand Dollars (\$90,000) for the first year of the Agreement, ending January 6, 2016. City shall pay Consultant an annual amount not to exceed Thirty Thousand Dollars (\$30,000), at the rates or charges shown in Exhibit "B", for the duration of the Agreement, including any extensions or renewals."
