

1 FIRST AMENDMENT TO AGREEMENT NO. 31887

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 31887 is made and
4 entered, in duplicate, as December 20, 2011 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 13, 2011, by and between TETRA TECH WEC, INC. DBA KFM
7 ENGINEERING, a California corporation, with a place of business at 17885 Von Karman
8 Avenue, Suite 500, Irvine, California 92614 ("Consultant"), and the CITY OF LONG
9 BEACH, a municipal corporation ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed in connection with As-Needed Engineering Consulting Services; and

12 WHEREAS, the parties entered Agreement No. 31887 whereby Consultant
13 agreed to provide As-Needed Engineering Consulting Services; and

14 WHEREAS, the parties desire to increase the Agreement amount by
15 \$300,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 31887 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed Three Million
25 Dollars (\$3,000,000), at the rates or charges shown in Exhibit "B".

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 31887 are ratified and confirmed and shall remain in full
28 force and effect.
